# A Semiotic Perspective on Cemeteries: Interpretation, Art, Scenery

## Introduction

This paper is oriented to provide discussion on elements of North American cemeteries through a semiotics [[47]] focused lens. Each section, bar the introduction and conclusion, will investigate some aspect of cemeteries according to one or more semiotic concepts.

The second section of this paper titled "A Historical Rest In Peace", will provide historical context for cemeteries found inside the continental united states. Explanation will be given regarding the various types of burial/ cemetery practices from cultures in many times and places across the modern-day United States. Cemeteries are evidently "marked" places, carrying with them varying degrees of significance for those whose cultures and traditions relate.

The third section of this paper, titled "Perceptions of Cemeteries", explores the perceptions associated with exploring cemetery spaces. Care will be taken to discuss elements of firstness [[14]], secondness [[46]], and thirdness [[64]] are illustrated in cemetery spaces; specifically, through a lens of natural beauty and emotion of cemetery space ((7)).

The fourth section of this paper, titled "Symbology in Cemeteries", explores the connotation [[6]] and denotation [[9]] of etiquette, inscriptions, trinkets, and monuments/ structures commonly practiced and found in cemeteries ((2, 10)).

The fifth section of this paper, titled "Functions of Communication in The Cemetery", relates the emotive [[13]], connotative [[3]], referential [[43]], poetic [[38]], phatic [[37]], and metalingual [[27]] functions of communication present between cemeteries and the living.

The sixth section of this paper, titled "Grave Traditions in Cemeteries", delves into the changes in attitude and interpretation of cemeteries regarding the significance of symbolism in cemeteries. Specifically, such symbolism will be analyzed under the lens of postmodernism [[39]], with emphasis on pessimism, abstraction, individualism, and the challenging of social constructs with respect to one's choice of inscription on their grave.

The seventh section of this paper, titled "Changes in Cemetery Scenery", analyzes the transition of cemeteries from urban spaces to a more private environment. Special care will be taken to discuss the change in the general public's paradigmatic [[34]] perception, image schema, [[21]], and proxemics [[42]] of rural cemeteries as they are seen today.

The eighth section of this paper, titled "Last Landscapes" explores the paradigms [[34]] and syntagms [[61]] regarding the signs and physical spaces of cemeteries. Specific exploration will be made regarding what constitutes a category of a cemetery with respect to its signs and landscape ((3)).

The conclusion of this paper summarizes the semiotic concepts which this document applied to cemeteries throughout each section.

#### A Historical Rest In Peace

# Conclusion

This paper covers some significant ideas from the perspective of a semiotician and applies them to a relatively focused lot of phenomena associated with cemeteries. The specific semiotic concepts discussed in this paper considering cemeteries under a fresh lens is found in the following list, which summarizes the topics and discussions in each section.

- Cultural background and history regarding cemeteries in the USA, describing how the markedness of cemeteries has evolved, noting specific differences between burial grounds of different societal systems.
- Saussurean elements of firstness, secondness, and thirdness as they can manifest themselves within cemeteries. With a specific example of thirdness being the myth and representation regarding kinesics and gestures seen in cemeteries both in person and through art.
- The connotative and denotative notions with respect to cemeteries were used to distinguish between the "face-value" and subjective meanings regarding symbolism of the dead.
- Roman Jakobson's six functions of communication, those being the emotive, connotative, referential, poetic, phatic, and metalingual functions, were all defined, and applied to gain a better idea of the relationship(s) between the living and cemeteries.
- Elements of structuralism and poststructuralism were discussed; specifically, regarding notions of pessimism/ optimism respectively, and abstraction/ conventionality with respect to cemeteries. Additionally, elements of structuralism and the overall presentational nature found in rural cemeteries such as the Oswego Rural and Riverside Cemeteries.

- Both the image schema regarding cemeteries and the presence of discursive symbols as they appear in said cemeteries. Examples of cemetery codes being followed were also discussed.
- Paradigm and syntax were described as they relate to cemeteries, with additional commentary being made with respect to codes and how they relate to the layouts and categories of cemeteries.

This document aims to serve as am example of how one might consider aspects of cemeteries from the perspective of a semiotician. Such a task is achieved by applying a semiotic-oriented mindset to the culture, inscriptions, and landscapes typically associated with spaces of the dead. Ideally, this paper may introduce or enhance one's appreciation, knowledge, and understanding of the complexities of cemeteries as they are today.
