 (T) Effects of Hanyu Pinyin on Pronunciation in Learners of Chinese as a Foreign Language (A) Benedetta Bassetti (P) Beijing Language and Culture University Press (D) 2007

This article discusses Pinyin, the phonetic alphabet used in China, and how it can be used to help non-native Chinese language learners learn Chinese words along with Characters. This resource will be useful when I discuss phonetic transcriptions and pronunciations of Chinese words and characters.

2. (T) The Quest for Meaning: A Guide to Semiotic Theory and Practice (A) Marcel DANESI (P) University of Toronto Press (D) 2020
